Capacity to translate into plans, projects and reports, the most adequate solutions for urban management problems, by giving them adequate training so they can be understood by technicians, political and business decision makers and general citizens;
Capacity to use modern technological resources adequate to the diagnosis and search of solutions and its representation towards the integration with complementary scientific areas and their own technological resources;
Capacity to work in a multidisciplinary team managing own partnerships at each situation while respecting the ethics and deontology of the profession;
Creation of learning habits throughout life, whether in a self-oriented and autonomous or an academic manner;
Capacity to design, organise, manage and develop scientific research projects, either autonomously or integrated in multidisciplinary teams.

The Doctoral programme aims to create a body of researchers and teachers capable of developing Urban Design, Land Planning and Management as a consolidated disciplinary field by training specialists in Planning, with a solid technical, theoretical and methodological training.

In particular, the Doctoral programme in Urbanism aims to achieve the following main objectives:

- Deepen the foundations and values which should be present in the act of creating and managing urban public space, opening up new paths in urban planning and design, especially as regards methods of urban analysis and of the composition of our cities' public space;
- Deepen the legal and operational knowledge regarding the implementation of municipality-based agrarian and urban regulation policies;
- Understand Transport Mobility and Planning with a systemic view of cities assimilating the concept of sustainable development;
- Understand the articulation between the national policies in the area of Urban Planning and the broader context of European policies;
- Deepen the role of strategic planning with instrumental recourse for the development of territorial harmonization in Portugal;

Under the terms of the law and of the consensus of instituted academic practice, the degree of Doctor will attest the achievement of an innovative and original contribution in the field of Urban Planning, a high cultural degree and aptitude for conducting independent scientific work.
